## PUBLIC COMMENT

It is not Interfering with the day to day. You are giving him the guidance. You need to find the money. An investment is saving you money in the long run. John Lauve, 200 N. Saginaw, said we had an election for police and fire, and we are not going to have any money for the police or fire, and he wants to know what is going to take place. The problem with the trailer park is the water runs off onto other property. The Township and the County has a responsibility. Trailer Park owners pay \$3 a month in taxes. That is nothing.

Mary Blanchard, 3444 Old Creek Drive, said thank you to Mr. Feeney. Congratulations to the new members. Falk Road Dump goes back to 1993. PFAS has been found in the last 3 years. After 25 years of no testing, we are grateful the contamination is not worse. This is the beginning of the process to determine the level of contamination. Recently she spoke to Rep Mueller's office. Congresswoman Slotkin said there are billions of dollars allocated to the State of Michigan. For clean-up. The Village will need to put a proposal together for Rep Mueller. Holly in general is not experiencing as severe contamination as other areas of the state. Falk Road dump there is a fish advisory coming. Both lakes have a fish testing that qualifies as a fish The final advisory is not known. advisory. Limit your intake of fish.

George Kullis, 601 E. Maple Street, said Mr. Gildner, thank you for the plaques. Kier's name plaque is spelled wrong. We live in a wonderful country that gives us the freedom for this evening. The election is over. From this day forward the best job in front of you is working together. The ability to work together. And the compromises. Wish you all the luck on that. Remember Larry Lilly. He passed away. He came to every Village meeting. Sometimes he scolded the Council. Sometimes he praised the Council. Debby, you have served for a long time on this Council. Sorry that your child had to be subjected to that. Jerry, Debby, Chief Narsh, Attorney Gildner – let's move forward. You can't change the past.

### **PUBLIC HEARING**

Clerk/Treasurer Bigger said this is for the Community Development Block Grant Funds. It is a grant we get every year. This year we have an estimated amount of \$20,892. We are allowed one public service for \$3,500. We have two organizations that have applied. Holly Area Youth Association and HAVEN. Council will make a choice when they vote on the resolution.

President Pro-Tem Musgrave asked for the numbers again.

Clerk/Treasure Bigger said the total is estimated at \$20,892. The public service is \$3,500. That leaves a balance of \$17,392. Staff is recommending that be spent on street improvements.

Candy Hovarter, 3128 Brighten Road, represents Meals on Wheels. We charge \$3.50 per meal. Some don't have the ability to pay for their meals. We try to fundraise. This would help. We give them food in the interim. We give frozen foods on the weekend. We feed them all the time. Also provides social contact during the day.

Councilor Brandon asked what area it serves.

Ms. Hovarter said Livingston County and some of Oakland County.

Councilor Brandon asked if they have any other grants.

Ms. Hovarter said AAA fund. Southeast Michigan. We ask for \$3.50 a meal. Over 60 and homebound. They have to get dressed.

Kristin Watt said it is wonderful that someone came to the meeting. She said it was a couple years ago for the non-profits to meet the needs. How do you split the baby. If she recalls, HAVEN got it the last couple of years. HAYA services Holly kids. I would love to see more organizations added to the list, but she advocates for HAYA.

George Kullis said in the past we have given the Village CDBG funds for the Smart bus. We are not doing that this year. They are starting those committee meetings. They will not reach out to us. Now we have to fund the Smart buses. Between Rose Twp and Groveland Twp and Holly Twp, they will get over \$942,000 a year. They clearly state it will be service county wide. We need to bring some of that money home.

Joanna Barnes said in regard to the 3 applicants we have tonight, 2 of them are larger. HAYA is a smaller organization. And a direct give back. Thinking about the citizens here. Take care of home first.

Angela Wallace, 709 Baird Street, said HAYA is organized and developed by volunteers. They offer school supplies. My daughter had a hard time fitting in, so she picked up vapes. This is real people in our community that they are touching. Our children are our future. They have not had many resources put into them. There was a girl in the high school that OD'd yesterday.

Ryan Shiel, 320 Legrand, said it is very important that we do this. In recent times he has noticed that it can help these teenagers from going around and spray painting everything. If we refer them to HAYA it can give them the mentoring they need. Prevent them from doing silly things.

Candy Hovarter, said she wants to be clear that the funds would be designated for Holly.

Mr. Kullis said these meetings are a live video tape, resident thanked him for talking about the CDGB funds.

She helped to organize the Run for the Dickens. Asked by Jerry Walker to serve on the Water Works committee. Covid redirected her. She ran for supervisor but lost to Mr. Kullis. She reviews the Planning Commission packets with her husband.

Lue Harting, 2700 Willow Lane, is the Director of choirs and theaters at Holly High School. Through my role that she comes before you to speak in support of Sherlynn Everly. She served under Sherlynn at the Renaissance festival. Always consider the details. Only as strong as the people around you. Sherlynn is strong with the heart of a servant. Sherlynn's family has been a part of the community. Bult her forever home.

They call her the theater grandma. She stays in the know and takes an active role. She listens to members of the community. Motivated to meet those needs. She can think of no one who can serve this Village.

Patrick Feeney said it is not a question of the person he has chosen. People at home would imagine there is no one else to be considered for this job. He is interested, but he wasn't seeing public notice that there was a seat available. Glad to see people supporting Sherlynn, why was there not a notice about an available seat. One member didn't even know the process. He thought you would have stated there is a position open, here is what we are looking for. List the candidates. You can't say you are here for a change and then do the same thing. Asked Mr. Delaney if anyone else was interested. No reflection on anyone in here, but how do we get people involved if you do things like this. I'm going to assume that you tripped coming out of the gate. The fact is the process was not and it should have been.

Anna Matson, 1105 Western Valley, said she thinks going forward that you should have at least 3 candidates to consider. It has nothing to do with who is being represented. But there should be at least 3 to pick from.

Keith Barnes, 3393 Herrington Drive, said congratulate the new members. As far as Mr. Winebrenner, he would like to see a person of color up here.

Marlo Davidson said, she would like to see Buster Winebrenner. He has experience. This is his hometown.

Angela Wallace said they spoke who they wanted. She doesn't know Mr. Winebrenner. Her vote was swayed away from Winebrenner to Kinnamon. The people spoke loud and clear. Please look for other people who have not served, people who will work together instead of against.

President Delaney asked if council would like to add Meals on Wheels to the list of options.

Councilor Kinnamon said yes.

President Pro Tem Musgrave said yes.

Councilor Kinnamon said funds that go to HAYA sit for years. Most of their clientele don't fit the parameters. It should be a budget item. Would rather see us take that route.

Manager Walker said we are not going to recommend giving general fund money to HAYA as we do not yet have an adequate fund balance. He values HAYA just because there are strings attached, you should learn how to use the money with the strings attached.

President Delaney said it has been 3 years since we have allocated funds to HAYA.

Kristin Watt said if HAYA has money that hasn't been used.

Manager Walker said they have spent all of their money.

Councilor Kinnamon said he does value what they do.

President Pro Tem Musgrave said we didn't give it to them for a couple years because they didn't spend it.

Mr. Kullis said that money has been spent, that is why you have an application for this money.

Mr. Shiel said he echoes what Councilor Kinnamon said, there are restrictions to that. If you allocated the budget line item, it would be an unlimited amount that they could use any way they want.

#3. Consideration of the Approval of Council Action Request to Authorize the Village Manager to Execute the Contract for the Demolition of 400 Elm Street.

Manager Walker said he would like to postpone this item. This building is secured. It is a blight issue. We have gone through all the steps with the asbestos testing and the lead testing. Structural engineers and soil erosion work. Demoing the building would be a good thing. Oakland County notified us that it is going for the tax foreclosure process. All of the money we have spent, no guarantee that we would get any money back. We were asking you to approve \$148,000. We would like to spend a little more time to work with Oakland County to see if there are any avenues to take. The building needs to be addressed. Before we commit to spending that amount, we want to be able to work with Oakland County a little more.

Councilor Perkins asked if it goes to tax sale, will it carry over.

Manager Walker said we need to see if the current property owner will redeem it. And work with the new owner. It goes into the late winter, early spring.

Mary Blanchard said she recommends that you have it checked for PFAS because it could come back on the Village.

Angela Wallace said when Vern went missing we walked that property Mr. Perkins said it was lucky you didn't get shot. There are several loading docks, filled with water. Is the building

secure or the property secure.

Manager Walker said the building is secure.

Angela asked if the water was still there.

Manager Walker said the Village doesn't own that property so the Village can't do anything on that property without a court order.

Councilor Perkins said Chief Narsh, and I have chased many children from that property.

Angela Wallace asked if you could secure the perimeter.

Manager Walker said, we have no rights except under the property maintenance code.

## #4 Consideration of the Approval of Council Action Request to Approve Ordinance 471

Manager Walker said ordinance 471 has to do with the property maintenance code. Currently it is only the Village Manager or the code enforcement officer. We think with the PD doing code enforcement and compliance will be better. These are specially trained part time or reserve officers. It will allow for Jeremy Watson to concentrate on areas in the historic downtown. Preservation of the downtown. Have uniform police in the neighborhoods. Allow for the Village Manager to designate someone.

Chief Narsh said currently the property code asks for everything to be a misdemeanor. This will change them to civil infractions. Don't like the idea of charging misdemeanor crimes.

Councilor Kier said you have the ability to give that power to someone else in your absence. Should we list who that person is.

Manager Walker said we have started that process. We will continue to do that education. Talk about it in public meetings.

Councilor Kier asked if we could name the people responsible.

Attorney Gildner said the issue would be every time there is a change in personnel, we would have to amend the ordinance. Prepare this to allow the change.

Chief Narsh has the article half written.

Joanna Barnes said I'm on the HOA board and we go around and make sure houses are up to our standards. No outside enforcement. We live in Millpoint. The north side gets forgotten. She has rodents coming into her garage. No one has been able to do anything about it. Only concern is that these officers. She saw at least a dozen houses that have garbage piled up. We are allocating resources to cover the downtown. More than just handling it. Enough resources to do it right.

Councilor Kinnamon asked if we have been more of a complaint response.

Manager Walker said that is true we are complaint driven. 2 people will go out and proactively seek out violations. This will meet both needs. They will change. This is the first step.
